The undersigned Current Account Holder(s) (whether singular or plural, "Transferor") associated with the Seat Renewal Rights to the seat location(s) and race(s) identified above does hereby request to transfer, sell and assign ("Transfer") all right, title and interest in and to the Seat Renewal Rights identified above and all related rights and obligations to the New Account Holder named below (whether singular or plural, "Transferee"). Transferor and Transferee acknowledge that the Transfer will be complete only upon approval by Talladega Superspeedway ("Talladega"). Talladega reserves the right to request additional information and/or to deny this transfer request for any reason.

By signing this Transfer Request Form, Transferor knowingly and voluntarily: (i) represents and warrants to Transferee and Talladega that Transferor has full authority, power and right to Transfer the Seat Renewal Rights free and clear of any interest or right of any other party; (ii) agrees that the effect of this Transfer, if approved by Talladega, will be to transfer, assign, and relinquish all right, title and interest in and to the Seat Renewal Rights and (iii) releases Talladega from any further obligation or liability to Transferor with respect to the Seat Renewal Rights or the Transfer set forth in this document.

By signing this Transfer Request Form, Transferee knowingly and voluntarily: (i) agrees to accept the Transfer of the Seat Renewal Rights identified above; and (ii) upon approval of the Transfer by Talladega, agrees to assume all obligations of the Transferor with respect to the Seat Renewal Rights; and (iii) agrees to accept and abide by all applicable rules and regulations of Talladega, which may be amended at any time in the sole discretion of Talladega, including rules and regulations relating to the revocation of individual tickets, season tickets, and Seat Renewal Rights; and (iv) releases Talladega from any further obligation or liability to Transferee with respect to the Transfer set forth in this document.

INFORMATION REGARDING TALLADEGA SUPERSPEEDWAY TRANSFERS

No transfer will be complete until the Transferee has assumed all obligations of the Transferor. The Transferee must be at least eighteen years of age to enter into a binding contract. Both the Transferee and Transferor must sign and return the Transfer Form.

A transfer request must include verification of both the Transferor and the proposed Transferee. Such identification verification may include a photocopy of the driver's license, state identification card, or passport.

If the Account Holder of Record is deceased, a photocopy of the Death Certificate must accompany the Transfer Form.

If the account is in the name of a business, a letter of authorization on company letterhead signed by an officer of the company must accompany the Transfer Form.

Transfer requests are accepted year round, but the execution of the transfer may be delayed if the request is made during the process of distributing tickets to Account Holders.

A transfer processing fee of \$15 must accompany each Transfer Form. Make checks payable to Talladega Superspeedway or fill out the credit card information on the Transfer Form.
